n her early 30's, Aimee was diagnosed with Huntington's Disease, a rare, progressive, and deadly disorder causing involuntary movement, cognitive decline, and psychiatric symptoms. As a hereditary condition, Aimee's mother had suffered and ultimately succumbed to this devastating disease. Today, even though Aimee is chair-bound and has difficulty speaking, her inner strength touches and inspires all who know her.

Aimee is now 46 years old and facing the final stage of her life. With the love and care provided by her devoted father, David, and stepmother, Jeannie, we wanted to find a way to celebrate Aimee's passion and life experiences. We were honored to work with the family to assist them in creating a memory book capturing Aimee's life journey. Through the sponsorship of our generous donors, we were able to complete a three-volume treasured gift for her family.

Beyond that, Aimee had one final wish. Prior to becoming ill, Aimee was an avid concertgoer and she loved to attend them with her brother and many friends. In fact, she attended so many concerts that one family member was inspired to create a quilt from all her concert t-shirts.

Because of the fragility of Aimee's condition, her doctor would not allow her to travel from her home in Mission Viejo, CA. However, we made every attempt to reach out to her favorite band to request a video message for Aimee and we were thrilled when they responded!

The band, who has requested to remain anonymous, created a personalized shout-out, thanking Aimee for her many years of support. In the video message, one of the band members said, "It's so symbolic in a way. A quilt brings someone comfort and warmth, and that's what you want to do as a musician and as songwriter with your music. So thank you for all of your years of being with us at our shows and we are thinking of you, Aimee."

Knowing the heartwarming impact that a quilt can have on the quality of life, we have partnered with a nonprofit agency called Quilting for Community, ensuring that many of the patients served through our organization have the opportunity to receive a handmade quilt, sewn together with love. We know that these beautiful gifts will be cherished by the family for years to come, and we are so grateful for the band for their heartfelt response. Most importantly our hearts are filled with gratitude for our time spent with Aimee and her family.

In 2021, we met our million-dollar-match, a generous donation from an anonymous donor, who doubled the impact of every contribution to our Heavenly Home Living Legacy Endowment. This brought our Endowment to over \$2 million, and provides the financial footing and flexibility that will allow us to open our doors to the community. The Endowment will provide critical operational support for our resident's care, so that hospice patients in need of 24-hour-care can spend their final days in a home-like setting.

Consistent with our commitment to provide a welcoming environment, we completed the furnishing of the Heavenly Home with care and attention to both form and function for our patients and their loved ones. Because of people like you, the Heavenly Home is not burdened by debt —from the purchase of the home to the full renovation, lush landscaping and well-appointed furnishings. Together we have created a beautiful and sustainable property that will serve the Southern California community for decades to come. For all of this we are grateful.

Additionally, we completed and submitted the extensive application to license the Heavenly Home through the California Department of Social Services, ensuring that we meet all state requirements to receive and care for residents. This is a lengthy process, but once we are granted our license, we look forward to opening our doors and serving the many hospice patients who have been seeking the exact type of care the Heavenly Home provides. Until now, no option has existed, and as a result, this has created a vast unacknowledged housing gap for terminally ill patients across our region.

With the opening of the Heavenly Home, we remain steadfast in our commitment to meeting a wide range of socio-economic needs of hospice patients and their families. Through our Angel Assistance program, we continue to provide groceries and pay utility bills for families who are in need, while always looking for opportunities to grant fabulous wishes. Through We Honor Vets, a program that honors terminally ill veterans for their dedicated and selfless service to our nation, we continue to salute our soldiers. And through Community Outreach, which has included a food pantry and PPE distribution, bereavement workshops, and speaking engagements to share the special message of hospice, we continue to serve the needs of those affected by a catastrophic illness.

From the early days of the SoCal Hospice Foundation, all that we do has been made possible through the generous support of our friends and donors. Our greatest dreams and wishes for our patients have been answered through your commitment and partnership. We look forward 2022 with the same trust and big hopes for the terminally ill patients we serve. Around every corner, we see possibility and light.

he Heavenly Home is also known as Jerry's Heavenly Home. The Latin meaning of Jerry is "Sacred Name." In Hebrew it means "Chosen by God." We believe that the Heavenly Home will become a sanctuary of hope for all who enter its doors.

As one copes with a terminal illness, the traditional standard of hope for a cure often evolves to hope for comfort, hope for quality of life, and hope for the best care possible...reminding us that no matter where we are in our journey, there is always hope.

The Heavenly Home is Orange County's first and California's third nonprofit end-of-life care facility, dedicated to serving terminally ill patients who would prefer not to die at home; who lack access to care; whose loved ones cannot provide around-the-clock care; or who seek a loving, homelike environment to spend their final weeks of life.

While we look forward to our grand opening in 2022, it is important to also recognize our many achievements. Here are just a few of our Heavenly Home Highlights from 2021:

- We submitted the Residential Care Facility application for the Heavenly Home to the Department of Social Services and were granted a hospice waiver for 6 bed-bound hospice patients from the Orange County Fire Authority.
- Procured 9,421 items of PPE needed for licensing the Heavenly Home including face masks, KN95 Masks, face shields, isolation gowns, hand sanitizer, and gloves.
- We were granted property tax exemption for the Heavenly Home, ensuring that more funds will be used to further our mission.



• We achieved our One Million dollar match, bringing our endowment total to over 2 Million dollars, ensuring that no patient dies alone.





## **PATIENT HIGHLIGHTS**

Providing patients with love, dignity and support is at the core of our mission. Each day we strive to bring them comfort, whether it be spiritual, emotional or physical, and each day we are touched by their stories. Through our Angel Assistance Program, 56 patients were served throughout Southern California and 14 patients were served through our partner agency, the Hospice Foundation of Arizona. Here are just a few of their stories:

## JOSE

Jose lives in a small, onebedroom apartment with his wife of over forty years, Irma. Jose is receiving hospice due to heart disease. He also had a stroke several years ago that left him bedbound and dependent on his wife for assistance with daily living. Although Irma is 70 years old and is busy providing the loving care her husband desperately needs, she also continues to work to pay their rent and bills. No one should have to struggle to put





food on the table while facing the challenges of losing a loved one, so we were blessed to provide the couple with \$1,000 in grocery gift cards. Your support honors their lives and their love for one another. Thank you.

#### BRYANT



Bryant is a delightful 58-year-old gentleman with a positive and uplifting personality. Although he is in chronic pain and suffers a terminal diagnosis from COPD, Bryant welcomes each member of his hospice team with a bright smile and encouragement. To help Bryant breathe, temperature regulation is essential. However, Bryant could not



afford the basic items he needs to reduce the summer heat in his home. We were thrilled to be able to help Bryant by providing him with blackout curtains, curtain rods, a floor fan and an air purifier.

## DELORES



Her smile says it all!

### FREDRICK

Frederick was homeless and terminally ill when the mother of his children passed away. His children, ages 15 and 18, were moved into foster care because they had no one to care for them. Frederick, who is only 57, was ultimately able to move into a skilled nursing facility, where he is now receiving hospice.

But his greatest concern was his inability to see his children. Frederick's skilled nursing facility was a long drive from his children, and with his health failing and without a car or the financial resources to be able to afford transportation, his children were left grieving both parents alone. Thanks to your generosity, we were able to provide Uber gift cards that have allowed Frederick and his children to reconnect and make memories together in his final weeks of life.


## ANDREA MONI AND THE ORANGE COUNTY CENTER FOR CONTEMPORARY ART

## 14TH ANNUAL HOSPICE GOLF TOURNAMENT - LIFE. LINKS. LOVE.

Every year, we gather at Pelican Hill to tee up, raise funds for our vital programs, and celebrate life together. While we could not gather in person this year due to Covid-19, we held a remarkable virtual golf tournament and silent auction throughout March. Golfers were invited to participate by playing at a course of their choice and sending in their score.

This is traditionally our biggest fundraiser of the year, and thanks to your incredible support, we netted nearly \$55,000. A huge congratulations to the AMAZING foursome winners: John Hornburg, Treb Heining, Bill Goring and Travis Physioc. Each of them has been supporters of the SoCal Hospice Foundation for many years and we are incredibly grateful for their unwavering commitment to our cause!

## **4TH ANNUAL PRESERVING DIGNITY - ONLINE COLLABORATIVE EVENT**

SoCal Hospice Foundation partnered with the Orange County Community Foundation (OCCF) to host Preserving Dignity, a collaborative 24-hour Giving Day on July 14 to generate support for nonprofits serving Orange County's older adults in need. Southern California Hospice Foundation had 63 donors who helped raise \$263,040 to support the Heavenly Home Project, slated to become Orange County's first nonprofit end-of-life care home. In total, OCCF's Giving Day raised \$389,684.

In Orange County, there are more than 450,000 adults aged 65 and older, which accounts for 14.3% of the population. By 2045, this number is projected to increase to 17.3%. According to the Orange County Strategic Plan for Aging, adults will face a new set of economic, social, health, and lifestyle challenges associated with aging, and Orange County is not able to provide adequate support of this growing population.

We would like to give special thanks to a member of our Hospice Advisory Council and the founder of our Hospice Guild, Vana Surmanian, and her husband, Michael, for their generous



donation of time, talent and treasure. Their continued support has played a significant role in helping us bring the Heavenly Home to fruition. Additionally, we want to give a big thank you to Fairhaven and Rose Hills Memorial Park for donating a \$25,000 check during our Preserving Dignity campaign. By building a \$2 million Endowment, we will be able to



cover a portion of Heavenly Home's operating costs, allowing greater access to care for our community. We are so thankful to have partners like Dignity Memorial who continue to support our programs and patients in such a meaningful way.

In addition to SoCal Hospice Foundation, other participating organizations – all of which offer a range of supportive services – included Alzheimer's Orange County, Council on Aging – Southern California, Human Options, Inc., Meals on Wheels Orange County, SoulRapha, and St. Francis Home of the Franciscan Missionary Sister of the I C Inc.


